New research into autism and gender dysphoria

The study published in <u>Autism</u> investigated the perspectives of clinicians working with autistic patients who experience gender dysphoria, and whether they work differently with this patient group.

# Children with disabilities at high risk of violence

The global study of more than 16 million young people reveals that young people with mental illness or learning disabilities are particularly vulnerable to violence, which can have a serious and long-lasting impact on their mental health and wellbeing.

#### SEND system has become too adversarial, new report finds

### Digital Lifeline Project is the beginning not the end

During COVID, Learning Disability England helped with a project by the Good Things Foundation. The report says that this project has helped people feel less lonely and has improved their health and wellbeing. The Good Lives framework says education, health and social care commissioners and providers need to understand the 'digital divide' faced by people with learning disabilities.

# Health-care barriers prevent many autistic people from seeking medical treatment

In an online survey, autistic people reported that they often have trouble using the telephone to make medical appointments and experience sensory overload in waiting rooms, among other health care barriers.

# More than 500 Changing Places toilets to be built in England

The new facilities will be built in the top locations voted for by families, carers and users of Changing Places toilets. Research by the Research Institute for Disabled Consumers in 2021 found that country parks, open spaces, beaches, tourist attractions, motorway services and other transport networks were the most in demand locations for the toilets, as the journey to the destination is a key factor in planning a day out.

### Learning disability training for nurses could be mandated

The House of Lords has passed an amendment to the Health and Care Bill which could see learning disability and autism training become mandatory for healthcare staff.

#### Sexuality and Down's syndrome is the theme of new campaign (learningdisabilitytoday.co.uk)

The right of people with Down's syndrome to have an independent love life with access to sexual health information is the theme of a new campaign launched by Italian charity CoorDown for World Down Syndrome Day 2022. The awareness group has created a short video called <u>Just the Two of Us</u> which tells in a hyperbolic way how families, especially when it comes to love relationships, can become a cumbersome presence in the lives of people with intellectual disabilities. The strapline of the video is "Love needs space".

#### New moderated online platform for autistic young people

The <u>Ambitious Youth Network</u> will offer autistic young people aged 16 to 25 a platform to take part in peer support sessions, share experiences and find volunteering, work experience and employment opportunities. There will also be opportunities for them to work together and campaign for change.

### Local councils must stick to fixed time limits for EHCPs (learningdisabilitytoday.co.uk)

Every local council must keep to fixed legal time limits when reviewing the needs of children and young people with special educational needs and disability (SEND), according to a new High Court judgement.

### <u>Autistic children wait up to five years for an NHS appointment</u>

Figures acquired under the Freedom of Information Act show that children are having to wait up to five years for an NHS autism appointment.

# New autism clinicians reflect on skill gaps, gains after remote training

The pandemic has forced many health-care students to train online, raising concerns about their readiness.

#### DNA tags in placenta point to possible autism-linked gene

The gene, dubbed NHIP, is in a chromosomal region that shows unusually low levels of DNA methylation in placentas from women who gave birth to autistic children.
