Anticholinergic burden for prediction of cognitive decline or neuropsychiatric symptoms in older adults with mild cognitive impairment or dementia

There is low-certainty evidence that older adults with dementia or cognitive impairment who have a significant anticholinergic burden may be at increased risk of death. No firm conclusions can be drawn for risk of accelerated cognitive decline, neuropsychiatric disturbances, decline in physical function, or institutionalisation.

UK DRI report urges action to reduce health inequalities in dementia

The UK DRI <u>published a new report</u>, detailing the impact of scientific research on health inequalities for people affected by dementia. As the report launches at the start of World Alzheimer's Month, the UK DRI is urging the Government to prioritise funding for scientific innovation, to facilitate larger dementia trials, remove barriers that stop people taking part in research and close the gap on health inequalities.

Recruitment to dementia trials lags behind other major health conditions -
